§ 1

The **Promoter** declare that it is the organizer of the symposium **New Trends in the Metallic Materials Processing, 4th edition** which will take place on 16-18.05.2023 in Bucharest, Romania.

§ 2

1. The **Promoter** obligations are to carry following promotion actions dedicated to the **Promoted Company**:

- Free participation for 1 person at the events connected to the symposium (symposium, welcome cocktail, lunch, official dinner).
- Free advertisement (1 page) in one of the issues of the Romanian Foundry Journal in 2023 (polychrome or B&W, article or advertise).
- Booth in the lobby of the symposium hall consisting of a desk, two chairs and 4 display panels (1 x 2 x 1 m).

§ 3

1. For all services mentioned in §2, the **Promoted Company** will be charged by the **Promoter** with the amount of 450 Euro (four hundred fifty) or 2.250 RON (two thousand two hundred fifty).

within 7 days from the date of receipt of the invoice, indicating in the payment order "Promotion during the symposium NTMMP, 4th edition".

3. All bank costs have to be paid by the sender (**Promoted Company**).

4. The **Promoted Company** authorizes the **Promotor** to issue invoices with immediate effect.

§4

1. The **Promotor** reserves the right - in the event of circumstances beyond its control, in particular the introduction of restrictions related to the COVID-19 epidemic or military conflict, to change the symposium formula to on-line or hybrid (stationary + online).

2. If the symposium is organized in an online or hybrid form, for reasons beyond the control of the Sponsored, the Sponsor is not entitled to a refund of the amount indicated in § 3, and the actions indicated in § 2 will be adjusted to the adopted form of the symposium.

3. In the event of:

a) canceling the symposium - the **Promotor** will return to the **Promoted Company** the amount indicated in §3 less the amounts necessary for promotional activities for the **Promoted Company** until the symposium is canceled,

b) postponing of the symposium to a new date for reasons beyond the control of the **Promotor** results in the transfer of the fee paid by the **Promoted Company** to the next date of the symposium.
