## **PARTICIPATION REGULATIONS**

## International Symposium "New Trends in Metallic Material Processing", 4<sup>th</sup> edition May 16-18, 2023, Bucharest

- The Organizers of the International Symposium "New Trends in Metallic Material Processing" (NTMMP 2023) are the "Politehnica" University of Bucharest, Faculty of Materials Science and Engineering, Department for Metallic Materials Processing and the Romanian Foundry Technical Association (ATTR) with the support of the Polish Foundrymen's Association.
- 2. The condition for participation in the symposium is registration via the on-line application form available on the symposium website: <a href="https://newtrends.foundry-conference.com/">https://newtrends.foundry-conference.com/</a> by April 30, 2023.
- 3. Symposium registration includes a few categories of participants: Lecturer (university, R&D Institution) / Lecturer (student) / Lecturer (company) with an oral presentation and Participant Standard / Student / Accompanying person and Company Promotional Package.
- 4. The Participant who wants to present a paper at the symposium must register through the registration system and upload the abstract. Information about abstract acceptance will be sent within 14 days. The deadline for abstract submission is March 31<sup>st</sup>, 2023.
- 5. After abstract acceptance, the invoice will be prepared and sent to the participant by e-mail.
- 6. Payments should be done by bank transfer to the ATTR account in maximum 7 days after receiving the invoice but not later than April 30<sup>th</sup>, 2023, without any claim for a refund in the case of absence of the person registered for the symposium (see paragraph 12.b Conditions for resignation).
- 7. Applications sent after May 1<sup>st</sup>, 2023 will not be considered.
- 8. The condition for participation to the symposium is that the full participation fee is credited to the ATTR account no later by April 30<sup>th</sup>, 2023.
- 9. Participants are required to individually book rooms directly in the Hotel and pay the appropriate fee. The conditions for booking rooms are specified by the Hotel. The Organizers are not responsible for the rules formulated by the Hotel.
